**Instructions:** Any applicant for the Natick Public Schools who cannot produce a property tax bill or lease must ask the owner of the property where the applicant lives to complete this legal affidavit in the Superintendent's office. It is the responsibility of the applicant (not the person who completes this affidavit) to attach a record of recent rent payment unless this affidavit affirms in Item #3 below that the tenancy does not require payment of rent.

The information contained in this legal affidavit is subject to verification by a residency investigator. Should the investigation determine the pupil is not residing in Natick; the signatory will be responsible for the cost of tuition for the days enrolled. The current per pupil tuition is set at a rate of \$16,745 (2020) and the per diem rate for attendance is \$93.02. This rate will be updated yearly upon completion of appropriate reports and confirmation from the MA Department of Elementary and Secondary Education.
