Disciplinary Policies, Procedures and Consequences

Disciplinary Policies, Procedures and Consequences as outlined were designed to promote student responsibility, respect for the rights of others, and to ensure the orderly operation of the district's schools and school sponsored events.

No handbook can be expected to list each and every offense which may result in disciplinary action. Instead, procedures were developed as administrative guidelines to ensure firm, equitable and consistent discipline. These procedures are based on the expectation that as students advance in age and maturity, they will assume greater responsibility for their actions. All district employees, parents and students are advised to read all information included in this handbook.

This Handbook governs conduct which takes place on school grounds or school property; on the way to and from school; on school buses and at bus stops; and at school activities whenever and wherever they may take place. In addition, the school district reserves the right to impose disciplinary consequences for any student's conduct (whenever and wherever it may occur) if such conduct is prejudicial to good order and discipline in the schools or tends to impair the morale or good conduct of the pupils. Finally, the school district reserves the right to suspend any pupil who has been charged, convicted or pled guilty in a court of general jurisdiction for the commission of a felony violation of state or federal law.

THE FOLLOWING DISCIPLINARY POLICIES, PROCEDURES AND CONSEQUENCES ARE NOT INTENDED TO BE A TOTAL POLICY FOR OUR SCHOOLS. EACH SCHOOL WILL HAVE ITS OWN SPECIFIED GUIDELINES CONCERNING STUDENT DISCIPLINE. THIS DOCUMENT OUTLINES BEHAVIORAL EXPECTATIONS OF A MORE GENERAL NATURE FOR ALL STUDENTS.
