Puyallup School District Bell Time Task Force Overview:

What: PSD is creating a Bell Time Task Force

- 1. Analyze current school start and end times across PSD.
- 2. Review best practices research provided.
- 3. Engage stakeholders, which may include surveying, and activating other resources such as PTAs/ PTSOs / school staff, community group meetings, etc.
- 4. Interface as needed with other departments working on related work such as maintenance and operations, transportation, facilities, athletics, management, and staff development.
- 5. Determine recommendations for bell times that may include: facilities, transportation needs, food services, master scheduling, training, communication, coordination, evaluation, and improvements.
- 6. Create a report for the Superintendent's consideration.
- 7. Create communications for stakeholder groups.

Who: The Bell Time Task Force will have three levels of involvement:

- 1. Steering Team who will do much of the preparation work.
- 2. Task Force that will meet to review the information and create recommendations for the Superintendent.
- 3. Stakeholder engagement through surveys, email, and focus groups (staff, PTA/PTSO, students, families, related departments, and project teams).

Why: Access to education and the health and safety of our students and staff is the most fundamental responsibility of each member of the education community. We want to ensure that the recommendation to move school start and end times, internal controls, training, and readiness are in place by the required date of implementation.

When:

This effort is starting in September 2022 and will be completed by June 2023.
