The information regarding the ESSER III plan was presented through DELAC and School Site Council to families and community members in person and via Zoom as well as through email and the school website. Collaboration and parent feedback regarding ESEER III funding was shared at DELAC and School Site Council meetings on May 18th, 2022. Parents and the community were invited to participate in the meeting through social media, district wide phone calls and posted on the district's website. All stakeholders were also encouraged to participate in surveys that addressed the LCAP’s four priority areas (the survey was posted on the district’s website and communicated through social media- the survey was open to all parents during the month of May 2022). The following stakeholders participated in the meetings: Parents, student representatives (representing English Language Learners, students with disabilities, low income and students of color), community members, teachers, classified staff, district, special education administration and site administration. All community members were invited to attend School Site Council meetings. None of the representative participants attending expressly identified as representing a tribe, homeless, foster, Civil Rights organization, children who are incarcerated or migratory students. Riverside Preparatory School does not have a local bargaining unit.

After sharing this data with Stakeholders, there was a shared agreement that resources should be put in place to ensure a safe environment that supplies ample ventilation and proper air conditioning and heating. Participants also agreed that additional support in the primary grades would align with the LCAP goal of ensuring all students were at grade level in both math and ELA.

#### A description of how the development of the plan was influenced by community input.

During the community engagement opportunities focused on learning loss, literacy and student safety.

The community surveys as well as feedback from Riverside Preparatory School staff indicated that the severe learning loss required more than the traditional intervention pull outs that have been provided. By providing instructional aides, teachers will be able to work in small groups and individually with students that are struggling and have been most affected by the learning loss that took place as a result of the COVID 10 pandemic.

The teacher and parents discussed in survey data and School Site council meetings the need to modernize the primary elementary building that was built in the 1940s. This building has windows that no longer open to the outside and the HVAC modernization that has taken place over the years has been limited due to the age of the building. This modernization will help with increasing ventilation and air quality.

The funds from ESSER III are being utilized to address these specific issues. Riverside Preparatory School recognizes the need to support students' health and academics. Funds from the ESSER III will ensure these initiatives have the necessary resources to be accomplished and address concerns from the community input.

# ESSER III Expenditure Plan Instructions

## Introduction

School districts, county offices of education (COEs), or charter schools, collectively known as local educational agencies (LEAs), that receive Elementary and Secondary School Emergency Relief (ESSER) funds under the American Rescue Plan (ARP) Act, referred to as ESSER III funds, are required to develop a plan for how they will use ESSER III funds to, at a minimum, address students' academic, social, emotional, and mental health needs, as well as the opportunity gaps that existed before, and were exacerbated by, the COVID-19 pandemic.

- Written in an understandable and uniform format;
- Written in a language that parents can understand, to the extent practicable;
  - If it is not practicable to provide written translations to a parent with limited English proficiency, the plan must be orally translated for parents
- Provided in an alternative format to a parent who is an individual with a disability as defined by the Americans with Disabilities Act, upon request; and
- Be made publicly available on the LEA's website.
