- Survey Discussion:
 - Jill Newell, Gallup presented information on employee engagement and the Gallup Q12 survey. The cost for the Q12 survey with professional learning and executive presentation of results for 1,200 employees is \$22,500 or \$19,000 for 1,000 employees. Board members questions were answered.
 - Bill Foster, School Perceptions presented information on staff surveys. The cost for 600 staff members is \$2,950 for the survey and additional fees for customization and reports. Board members questions were answered.


