TITLE IX

"No person in the United States shall, on the basis of sex, be excluded from participation in, be denied the benefits of, or be subjected to discrimination under any educational program or activity receiving Federal financial assistance..." 20 U.S.C. § 1681(a).

Title IX of the Education Amendments of 1972 (20 U.S.C. § 1681et seq.), is a federal civil rights law that prohibits discrimination on the basis of sex in education programs and activities. Under Title IX, discrimination on the basis of sex can include pregnancy discrimination, sexual harassment or sexual violence, such as rape, sexual assault, and sexual coercion. Title IX also requires that equal opportunity in athletics be provided.

Title IX prohibits retaliation for raising a complaint under Title IX or for advocating for a right protected by Title IX.
