Contiguous Parcel Tax Exemption Application
Instructions

1. This parcel tax exemption is for property owners who own parcels that are contiguous, used solely for owner occupied, single-family residential purposes, and held under identical ownership.
2. This parcel tax exemption allows for such parcels to be treated as a single “parcel” for purposes of the levy of the education parcel tax.
3. The Measure A parcel tax requires a yearly renewal by June 15 of each year to claim an exemption for the term of the tax that begins the following July 1st.
4. The parcel tax applies to parcels with land value. If your parcel is taxed for improvement value only (as in some mobile home parks), the parcel tax will not be assessed on your parcel, and you do not need to fill out this application.
5. To find your Parcel Number, look for the 8 digit number (XXX-XX-XXX) on your property tax bill, or call the County Assessor at 408-299-5500 for Santa Clara County. The Parcel Number for Santa Cruz County is listed as XXXXXXXX and the Santa Cruz County Assessor’s telephone number is: 831-454-2510.
